EFFECTIVE JULY 1, 2016 Use of School Facilities Fee Schedule

The Folsom Cordova Unified School District recognizes three classifications of facilities use: Classification I, Classification II, and Classification III. Generally, groups that may be considered Classification I are: youth sports groups with volunteer coaches (little league, youth soccer, etc.), scout troops and affiliated organizations, senior citizens, fire and police departments, etc. Classification II is categorized as non-profit groups (AAU Teams) and churches. Classification III is classified as commercial and for-profit groups.

Wages for district employees (custodians, cafeteria workers, etc.) will be charged as needed for opening/closing and cleanup. A custodian fee will be charged if the use requires an employee to be on site other than his/her normal working hours. Overtime charges may also be imposed if the use requires the employee to perform additional duties above his/her normal work duties (i.e., setup and take down 100 chairs in an auditorium).

This fee schedule, other than the Facility Use Fees for Personnel, does not apply to school-sponsored programs, including student body activities and meetings, parent/teachers' associations, parent booster clubs, school employee organizations and school advisory councils. <u>Applications are valid for a period not exceeding three (3) months</u>. A complete schedule including dates and times of use should be entered into Civic Permits <u>https://fcusd.civicpermits.com</u>. Field users must include the number of fields to be used. Insurance will be required prior to approval of use for all facilities.

All organizations will pay an application fee and/or an hourly rate. All Classification I, II and III applications for Multi, Gym, Stadium and Theater use will pay an application fee and an hourly rate. The application fee will be a one-time charge for <u>each</u> facility used by an organization. All fees must be paid within 30 days of invoice date or a 10%, or more, late fee will be assessed. If fees, such as tournament, admission, participation fees, or donations are collected by the applicant, or organization, the hourly rate and application fee will be assessed, and tournament/camp form must be completed. Exceptions may be granted by the CFO or designee.
